a. Director's Report Minutes:

> **All-PAC meeting**—SDERAEC Executive Director Gary Schwartzwald gave a brief overview of the All-PAC meeting that was held at Health Occupations Center on April 8, 2016. Ute Maschke went into more detail about the meeting stating that the goal of the meeting was to communicate to all PAC members what has been achieved by the Consortium and gather input to further define educational maps/pathways for Adult Education programs. The meeting involved students

whose insights and recommendations contributed to outlining next steps for the PACs.

**Annual Plan for Year 2**—The Consortium is currently working on the plan (due July 15, 2016) and will address it at the August Board meeting.

**Subcontract Agreement**—Sally Cox summarized the agreement between GCCCD and GUHSD. The fiscal chain of distribution will remain as originally designed. The terms of the agreement will expire September 30, 2016 to accommodate 2015-2016 funding.

Advisory Committee Meeting—Robyn Wiggins outlined the expectations for the Adult Education Annual Community Advisory meeting to be held August 28, 2016. In addition to sharing the progress of the Consortium and a WASC update, the focus will be on identifying the skills an Adult Education student needs to successfully transition to further education or the workforce. Another topic that will be discussed is how best to market Adult Ed, "the best well-kept secret".

**Student Services Activities**—Ute Maschke shared the progress of hiring Transition Specialists. Nikki Middleton was hired as the Transition Specialist Coordinator. Interviews for two to four Transition Specialists are scheduled for the beginning of May.

**Potential Partnership (GKN)**—Gary Schwartzwald described his outreach to GKN, a large international company that is based in El Cajon. The Adult School will work with GKN to pilot classes in ESL, math, and blueprint reading intended specifically for their employees. The class(es) will start out with approximately 25 or 30 students. Upon successful implementation, GKN will help us reach out to other companies with similar needs.

#### V. INFORMATIONAL REPORTS/DISCUSSIONS

Accomplishments and Milestones Achieved—Robyn Wiggins gave a brief history of Adult Education funding from the state. Our consortium is one of 71 consortia in the state and one of five consortia in San Diego County. This group of five, called the Super Region, have joined together to share ideas, strengths, and weaknesses so no one member has to reinvent the wheel.

The Consortium has achieved many accomplishments up to this point.

- Our new name, logo, and tag line was revealed at the Adult Education Back to School meeting.
  - The new name, East Region Adult Education (ERAE), represents adult education throughout the region of East San Diego County.
  - The new tagline, Education That Works, provides a positive, goal-oriented image for students to achieve their goals.
  - The logo represents the mountainous areas, the sun, the districts represented, and success.
- A Business Services Coordinator position has been established and filled. This person will reach out to local businesses to help identify ways we can prepare our students to fill their vacant positions.
- Orientations have been developed and have been piloted for Academic Programs.

**Year 2 Planning**—Ute Maschke discussed the Year 2 Plan that was recently submitted and the goals for the future.

**Budget Updates**—Sally Cox stated that they are finalizing the process of transferring funds from the Auxiliary to GUHSD. The funds are due to be transferred by October. The Consortium is starting to look at long-term budgeting. The 2016-17 budget will be ready for the next Board meeting.

The state has allocated \$205,280 for data planning/tracking. These funds may be used to hire a consultant. Last year's funds were reported in three separate ways which gave us the ability to look at the same funds more carefully.

**Meeting Updates**—An AEBG Summit will be held in Sacramento November 1 and 2, 2016. Each Consortia must send four representatives. Ute will attend as the Grant Manager but the other three representatives will be selected upon reviewing the agenda.

**Year 2 (2016-2017) Budget**—Sally Cox gave a budget update. Grant money was transferred to GUHSD and MEUSD. There is a better understanding of the cycle as we are nearing the third year. Keep Budget Updates as an ongoing agenda item.

**Summary of Priorities and Recent Accomplishments Across Members**— Ute Maschke shared a PowerPoint presentation outlining the priorities an accomplishments. Priorities have been established and budgeted through June 2017. Dr. Miles also suggested that the priorities be principal and strategic based, not repetitive.

Program Area Councils (PACs) will be evaluating course content and updating curriculum in 2017. It was suggested that PACs do a presentation for the board during future meetings.

ERAE has established three (3) new programs plus two (2) programs that were introduced the previous year. The current plan is to expand transition services and budget money for curriculum writing. Dr. Miles suggested that 30-35% of the budget be allocated for new priorities/programs.

The Adult with Disabilities (AWD) PAC is working with GUHSD Special Education Department to determine the needs for students after they turn 22. Currently students are referred to East County Career Center (ECCC) to assist in job readiness.

Transition Services have utilized education maps, field trips, and ambassadors.

Robyn Wiggins outlined the next steps. The Consortium will be doing a needs assessment for adults in the MEUSD boundaries. There is also a need to target sectors outside of the healthcare industry. Eric Lund commented that job seekers are very diverse in some targeted sectors. The Consortium should explore the entire San Diego County, not just East County. Collaborate with other groups and expand the focus areas.
