1. Welcome/Introductions and Additions to Agenda

2. Approval of Minutes

- Possible focused meeting topics agreed upon
 - Structure and roles of [California Community Colleges San Diego and Imperial Counties Regional Consortium](#) and WDC – especially in light of new funding streams

Al briefly outlined and commented on the [Strong Workforce K-12/CTE Initiative](#). \$ 150 million ongoing Proposition 98 will be/is available for CTE incentive programs, administered by Department of Education. \$14 million ongoing Proposition 98 is available for to support Workforce Pathway coordinators, K-12 technical assistance providers, and consortia administrative costs. See also the ppt presentation [here](#). Al urged attendees to start drafting plans/proposals now and be mindful of the fact that the regional consortium currently doesn't have (sufficient K-12 representation).

Ute conveyed her impression that “adult learners” (the learners super region consortia work with most closely) are not truly considered yet during WDC meetings and that Prop 98 funding might not benefit our students (yet/enough). It might be beneficial for the super region to prepare a joint statement.

- Co-enrollments across educational systems
- Opportunities for super region wide collaboration:
 - Professional development/community event (to include staff from all consortia); could be facilitated by TAP
 - Data across the region

Diane stressed the importance of exploring the regional strands of our work and reminded attendees of previous meetings where such strands were touched upon. Ute volunteered to compile a list of such topics from all previous meeting minutes available.

- Reports – “How to” (e.g., by program area; hours for distance education)
 - IET programs
 - Human-Centered Design and the 3-year-planning process
 - Engagement with business/industry
 - Transition and student support services
 - Best practices to follow up/staying in touch with students (e.g., exit surveys)

5. Reports/Updates

- Conferences/Meetings

- CASAS Summer Institute: 1,267 participants; schedule included AEBG and WIOA strands; showcased best practices; 2019 SI will be held in OC (June 11-13); that tickets go fast is anticipated

- AEP field team meeting June 8, 2018:

Beatriz reported on CTE/pathways team, which is currently still engaged in learning a lot about existing (and well-working) models in Texas but also considering CA projects, such as the Guided Pathways Initiative. It will be crucial to develop pathways that pro-actively include adult schools.

Crystal reported on the partnership team, which had a hard(er) time getting going. The team spent quite some time developing a shared definition/understanding of the meaning of "partnership." Super region meeting attendees agreed that partnership doesn't have to be about financial matters (right away). Rather, there are opportunities to push legislation (and to speak with one voice), and shared professional development might jumpstart partnership. Pam pointed out that as a super region we can consider ourselves a model for successful partnership. Pat reported on three action items for the data and accountability team: (1) clarifying services and developing common definitions (This is critical for any reports to the legislature – alignment with WIOA is a mandate and will also make things easier.); (2) identifying barriers to success and the implications such barriers have on measuring success and allocating resources; (3) determine how (and which) milestones especially for short-term CTE programs can be identified.

Vicki reported that KRA is still in transitioning period. KRA is currently and temporarily operating at ECCC; Escondido's office has been closed, but KRA is negotiating with the Work Well Center. All centers now have Wifi, which will make it easier for clients to access and utilize electronic services (including sign-in on your own device). SDWP and KRA want to get better with co-enrollments and with keeping costs of ITA down.
