#### 10. Super Region Reports/Updates

- Consortia Updates:
  - Welcome to South Bay and Sweetwater Adult School by Ryan Burke. Sweetwater will undergo some significant staffing and program changes over the next months. All consortia partners were encouraged to consider Sweetwater teachers for any open positions. All participants expressed their support and offered to work with students who might benefit from (and be able to take advantage of) classes and programs at other consortia and other sites.

## 12. Discussion Item #1: Sub-committees

- Proposal: *Set up a sub-committee to create an inventory of curriculum used across AE (and WIOA) programs – develop a region-wide, shared curriculum (student-centered; tailored to Adult Ed) – Meet for half a day to do curriculum walk; bring in WestEd as consultant*
  - There is general agreement that we should pursue this; start with a curriculum walk, perhaps in April. Consider national diploma; South Bay already started to revise their program(s); SD Adult Ed regional consortium already established process with high school
  - Consider getting in touch with OTAN (esp. distance learning)
  - Question: How would we account for/assess hours of instruction in distance learning?
  - Question: How do we connect/ re-establish connection with SD county libraries that now offer a diploma program?

## 13. Discussion Item #2 (Special Topic): Student Support and Transition Services

*How might we:*

- a. *Set up a super region-wide, community resource database of ed. plans (education maps; transition maps), contact lists for counselors/transition specialists, and transferal / release of information forms?*
- b. *Set up an efficient and supportive referral system so that our students can attend programs that best meet their goals, even if such programs are offered by another consortium?*
- c. *Provide orientation that is "high touch" and aligned with student's goals, skills, and interests?*
- d. *Measure our performance and success as TS (transitions, exists, even professional development)?*

*Anticipated Outcomes:*

- *Gain an understanding of best practices utilized at other sites*
- *Understand the needs and expectations of our communities (work culture included)*
- *Recommend first steps toward alignment of services provided by consortia*
- *Recommend first steps toward sharing of resources*

## The discussion evolved around two main questions:

Q: What is working in transition services?

A:

- Overall, communication improved; increase in referrals (teachers, clerks, students) = increased communication benefits student transitions
- Shared positions across ETCN; developed "Path to Palomar" and shared Student Education plans
- South Bay Partnership with Educational Opportunities Centers/Higher Education Center SWC
- Sweetwater/Southwestern tour each other's places
- Sweetwater is excited about the success that came with the introduction of orientations (among other things, it allows for the introduction of broader issues) – there are now considerations to introduce a second, career-focused orientation
- ERAE works with transition maps that allow for individualized approaches (and make space for the students' long term goals)

Q: What deserves another look and possibly revision?

A:

- Strengthen relationships with teachers and partnerships with stakeholders
- Need for job development positions
- We need to address students' financial barriers and challenges.
- Tackle transitions for students across consortia
- How do we develop a culture of "sharing" students?
- How do we break down program and consortium silos? (Internal and external marketing)
- Capture and share out data, also to celebrate our successes
- Can we develop holistic onboarding processes?

Next steps:

- Establish a dialog between SDWP and consortia – develop a true partnership
- Set up a bi-monthly transition services working group. (Andrea will lead this effort.)
- Create a shared file/electronic folder for FAQ
- Consider developing marketing materials that could work for us as a super region?
