- 1. Welcome/Introductions/Additions to Agenda There were no additions to the agenda.
- 2. Minutes were approved as read.
- 3. Super Region Reports/Updates
 - Consortia Updates
 - Coastal North County Adult Education Consortium: Governing Board has five members now; consortium is hiring a consultant for 3-year planning
 - South Bay: four working groups meet until Spring Break to work on strategic plan;
 - ERAE has six task forces set up for strategic planning. A steering committee will consolidate their work in March.
 - ETCN: Digital badging project is moving forward; will start issuing badges in February; initial student response looks promising; working on standardizing competencies for employers; the consortium could share results with other consortia. -> standardizing competencies could also become a joint project for the super region.

The consortium is one of only two in California that applied for WIOA grant and is now a recipient of FPM. Palomar College is running pre-apprenticeship programs together with San Marcos Adult School. Participants (10 right now) are not paid, meet three nights/week, 4 – 8 pm. Working on partnership with SD Sheriff department for Vista site.

- SDCE completed Human-Centered Design projects in process. Created joint marketing flyer across members and their HSD/HSE programs. (Flyer includes map for all locations.) Work on curriculum alignment. Currently working on a member effectiveness/accountability survey.

- 5. Discussion Item #1 (Special Topic): Transforming Partnerships San Diego Super Region and SDWP
 - Aligning Workforce Development and the Adult Education in the region Currently working on plan revisions, funding more robust evaluation. Super region participants emphasized the adult ed. (especially at K-12 adult schools) is an underresearched area.

Sarah Burns, SDWP Director of Research, presented updates to the regional plan – see appendix – participants commented positively on the intention to create more nuanced tools for programs and career development and reiterated the need to use the concept of "sustainable wage" rather cautiously. Kathleen Porter stressed the need to look at sectors and businesses that have entry <u>and</u> middle skills jobs (i.e., have growth in all areas). Robyn Wiggins cautioned that we also need to include students who are not eligible for WIOA funding. Sarah pointed to "income sharing agreements" as a possible option. (What would make students to buy into this model?)

Kathleen Porter also shared that Poway Adult submitted all their CIP codes.

- 7. A meeting for the super region curriculum and special stakeholder sub-committees followed.
 - Curriculum sub-committee: Crystal Robinson will take the lead; Ute Maschke will take co-lead, in organizing a workshop for second or third week of September. We might consider bringing in WestEd as a consultant. During that workshop, we will most likely
 - Do a curriculum/course walk-through to share best practices and concerns, and catalogue similarities and differences.
 - Consider which learners are not at the table (yet).
 - Review how we already work with Adult Ed College and Career Readiness Standards and state guidelines for HSD/HSE.
 - Introduce/develop together with the teachers/instructors a framework for teaching and learning.
 - Consider "what if" scenarios such as, "What if we made CTE classes one of a few alternative HSD options?"
 - Community/Stakeholder event sub-committee: We will table this for a later time. Ute will connect with the San Diego Regional Chamber of Commerce to arrange for participation in one of their regular meetings.
